... you will find information about the latest enrichment to our Instant Reporting API, which now includes Global Cash Pool account information. Information on local Swedish Cash Pool accounts are also included and other local Cash Pool accounts will follow.

A service which can help customers to collect money from customers and subscribers is MobilePay Subscription. It is available in Denmark and Finland and can be integrated with your systems to the benefit of the customers.

Next year we start a deprecation of SHA1 and existing users have to migrated to SHA256. First in line are FI/eGateway Web Services customers, but all Corporate Access customers using Secure Envelope will follow shortly after.

In the preparation for P27 in Sweden Nordea is introducing a sales stop for Bankgiro services from 1 February 2022. To support migration to Corporate Access Lite the free-period for the service will continue to the end of O2 2022.



Deprecation of SHA1 in FI/eGateway Web Services and Corporate Access

To provide more secured products and services to our customers, we will deprecate SHA1 and replace it by SHA256 in FI/eGateway Web Services and Corporate Access File Transfer with customer migration activities during 2022-2023.


The SHA1 certificates and signing algorithm will be replaced by SHA256 in

- Finnish/eGateway Web Services
- Corporate Access Secure Envelope for Corporate Access File Transfer customers using all communication protocols


Vendors and customers need to make own software change in order to be able to

- use SHA256 certificate and signing algorithm when creating the digital signature
- process Nordea's response messages which will be signed with SHA256 certificate and signing algorithm

We will do this change and migration for FI/eGateway Web Services customers first, and then for Corporate Access customers.



We will provide more detailed information about the change, and migration setup and timeline through newsletters to our vendors and customers along the migration.

Sales stop for BankGiro services and continuation of free period for CA Lite

Nordea will introduce a sales stop for the Bankgiro payment services starting 1 February 2022.

As previously announced the preferred offering to replace Bankgiro services is Corporate Access.

For ERP vendors who are supporting Nordea's customers we encourage you to ensure that your payment software supports Nordea's ISO20022 XML based payment messages.

It should also support Swedish payment types and reports.

To ease the transition for customers who are facing a migration from their current Bankgiro payment services as consequence of the P27 changes, Nordea will continue to offer Corporate Access Lite free-of-charge for the first half-year of 2022.
