Migrations from Bankgiro services (Leverantörsbetalningar, BG Lön and Bankgiro Inbetalningar) is ongoing with full speed for Nordea's customers, and the preliminary target is to complete the migration by end of Q1 2023. For quite some time we have prepared for this exciting development to take place, and we are happy to spread the good news with you!

The new service will give SME customers an even better experience by having full synchronization of data in the ERP system and in the customers preferred netbank – Nordea Business.

Customer value

First version of Corporate Access Lite in Nordea Business gives customers full overview of the payment files sent from the ERP or Accounting system, including status and reasons for rejections etc. In the next release customers can confirm and cancel payments and files in Nordea Business.

The integration with Nordea Business will also enhance the customer onboarding process, as they can order the service directly from the netbank. The new process will speed up the registration and increase quality giving customers a smoother and faster onboarding experience.

Is this relevant for you and our joint customers?

Yes, increased automation in payment processing and reconciliation is important for customers, and they are highly dependent on their ERP vendor to make this possible for them. This is also the target solution in the ongoing migration from Bankgirot to P27.

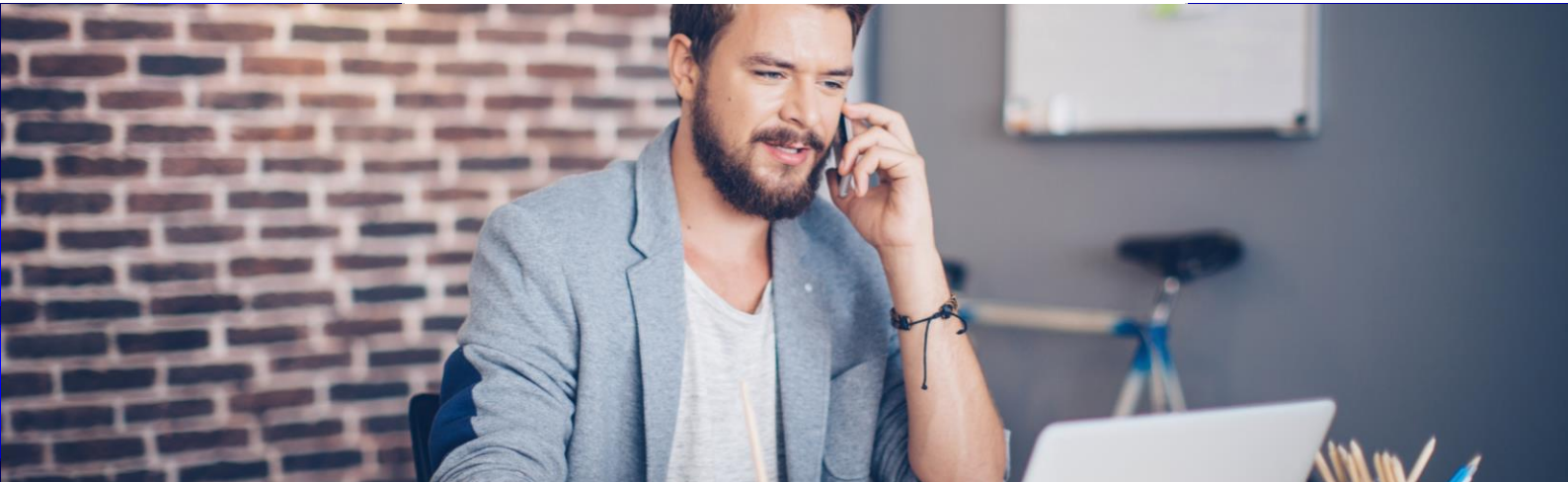
